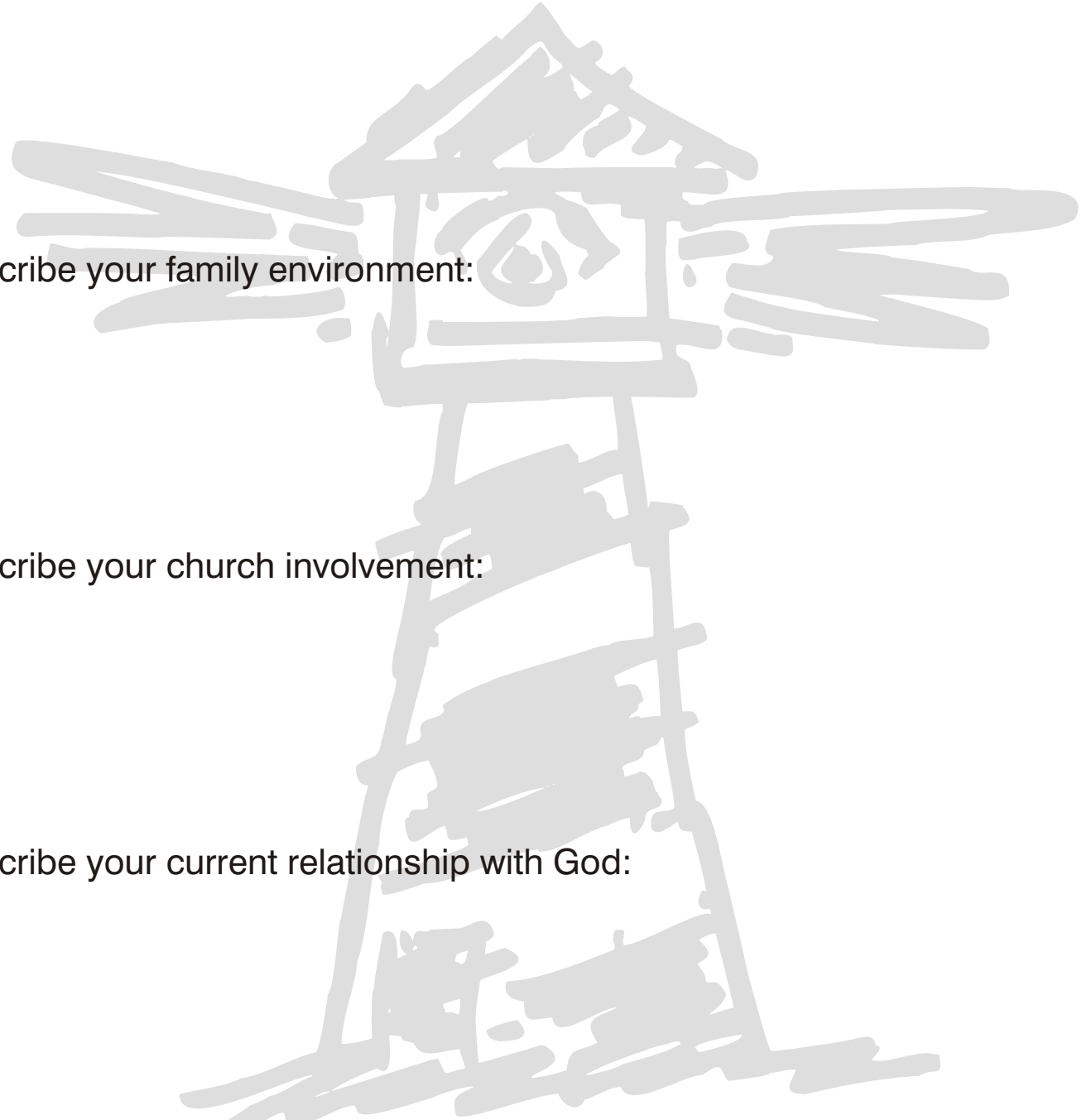

Rules of Conduct

The Rules of Conduct are for the safety and well being of each participant, as well as to keep a high standard of Christian integrity that is necessary to effectively minister across cultural boundaries. The Mission Staff as well as those in voluntary leadership positions will enforce these Rules of Conduct. We expect participants and parents/guardians to comply with disciplinary decisions made. All participants are expected to strictly adhere to the stated Rules of Conduct. Blatant offenders will be sent home. The offender and his or her parents/guardians are responsible for all costs or travel expenses involved in sending the disobedient participant home. As a representative of **futureVision Ministries, Inc.**, your church and the Lord Jesus Christ you are expected to consistently demonstrate excellence in the following, areas of integrity, honesty, morality and attitude. The following are rules of conduct that are in effect 24 hours a day. All participants must strictly adhere to them and are subject to dismissal without refund or reimbursement for disobeying any of the following rules.

The consequence for disobeying the following three items is to be automatically sent home.

- ✎ No romantic or dating relationships at any time.
- ✎ No use of or possession of illegal drugs, alcohol, or tobacco products.
- ✎ No pornographic material.

The consequence for disobeying the remainder of these rules will be immediate disciplinary action and possible expulsion from the trip.

- ✎ No profanity.
- ✎ No fighting.
- ✎ No secular music.
- ✎ Be on time to all meetings.
- ✎ No guys in girl's rooms, no girls in guy's rooms.
- ✎ Always let your leader know where you are going.
- ✎ Never leave the church complex or hotel area without permission.
- ✎ Remain in all meetings unless instructed to do otherwise.
- ✎ When you are in a service participate by worshipping, praying, listening and interacting with the people and the children.
- ✎ Do not eat or drink anything that is not served to you by the leadership of this trip unless you are instructed differently.

The purpose of **futureVision Ministries, Inc.** is the ministry of the Gospel of Jesus Christ and His Church. Any available sightseeing and shopping will be permitted only if it coincides with the team's main purpose, but could be canceled if not deemed convenient for travel time or if it hinders the ministry. Trip costs are based on current prices as of this writing and are subject to change. Dates, travel arrangements, and schedules are subject to change. Teams may be switched in event of any crisis - political, natural, or missions related. In the event of political unrest or natural disaster, **futureVision, Ministries, Inc.** decides if and where to send a team. Application fees and contributions are not refundable. **futureVision Ministries, Inc.** is a highly disciplined organization with regulations in many areas, including conduct, dress and Christian lifestyle. Team members, leaders, and staff adhere strictly to **futureVision Ministries, Inc.** policies and are subject to dismissal for disobedience, without refund or reimbursement. Team members, leaders, and staff serve at their own risk and **futureVision Ministries, Inc.** is not liable in the event of sickness, accident, death, or terrorist acts or for transportation or any other expense beyond that of normal involvement. All donations received by **futureVision Ministries, Inc.** go toward project expenses. To receive a tax deduction, the IRS stipulates that the donor must release control of the money donated to the non-profit organizations. For this reason, money cannot be designated to a person. The individual will be a fund-raiser and will get credit for raising the funds equal to the price of the trip. If an individual is unable to participate in the **futureVision Ministries, Inc.** experience, the funds he or she has raised, less incurred expenses and administrative fees, will remain credited to his or her account for one year. The **futureVision Ministries, Inc.** experience involves intense physical activity including extended hiking, continuous walking, and strenuous choreography. We require that all participants be in good physical condition and may request a physical exam and reference from a doctor. I have read and understand the above information. I also give **futureVision Ministries, Inc.** the right to use my picture, voice and/or testimony in any form of promotional or advertising materials.
